 - Berhad (ROC) Form 8, Form 23, Authorized Person Form / Letter & NRIC of the applicant / Passport
 - Foreign Company Authorized Person Form, Letter & NRIC of the applicant /Passport,
 Form 79, 80/80A, 83/83A
 - OTHER CATEGORIES :-
 - Law Firm NRIC of the applicant, Bar Council Malaysia acknowledgement letter.
 - Clinic NRIC of the applicant, letter from Malaysia Medical Council & Form 12
 - NGO / Others NRIC of the applicant, Acknowledgement letter from the related Ministry / Department
- Application for Personal Name MUST be include with NRIC of the applicant, authorized letter from customer, photo of the premise (outside, inside & unit number of the premise), customer's signature, agent Certified True Copy

All forms are compulsory to be submitted together starting 1^{st} July 2012.
